The sworn complaint of the plaintiff having been presented to me and after due consideration thereof, it is ORDERED, ADJUDGED AND DECREED as follows:

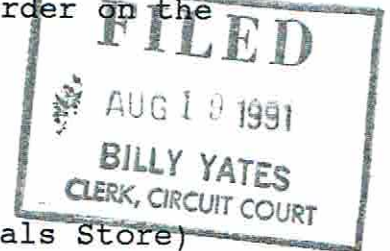
