- I. Call to Order** ~ by Chairman Stuart at 4pm.
- II. Pledge of Allegiance and Invocation** ~ pledge was recited in unison and the invocation was led by Council Member Lucas.
- III. New Business**
 - 1. Update on C-FUNDS – Tommy Darby, Treasurer** ~ explained that currently the balance is \$1,380,192.45. There are several commitments to **A) Lineberger** for \$395, 153.56 **B) Emergency Roads Repair (Blade & Hopps Brothers)** for \$91, 320.00 **C) State Road Requirements of 25% before June 30** is \$354, 000. The projected uncommitted amount for June 30th is **\$900,000.00**. Also the State

Appropriation money that came in was **\$2,942,074.92** with interest it's now **\$2,944,707.17**.

IV. Old Business

1. **Murdock Road update – LB Cannon** ~ talked about the residents that live on this road, what was resurfaced in 2010, the length that would need repairing, Duke Energy moving the poles and the Right of Ways. County Attorney Winters stated that an easement is needed to get the road widened. Chairman Stuart said that he would reach out via mail to the residents on Murdock Rd to see if they would be interested in signing an easement to have the road widened.
2. **Railroad update – Shane Stuart** ~ reached out to Steve Getney with the railroad concerning the TUB. He has reached out to his management about them paying for a portion of the TUB along with the County.
3. **Discuss and finalize a secondary roads list to be paved with the non-reoccurring funds allocated by the General Assembly** ~ Chairman Stuart sent out a sheet with the roads that each council member listed in their district. Per Bill Richburg Road is a State primary road and Rocky Creek Road is a County road therefore they are not eligible for this program. The roads that they Council approved to have worked with the C-Fund money are Lizzie Melton, Gardendale Circle, Scott Road, Davis Drive, Crestwood, Mt. Pleasant Road and ½ of West Brook. Motioned by Council Member Brad Jordan to do the roads on the list, with only ½ of West Brook and ½ of Mt. Pleasant roads being repaired, 2nd by Council Member Joe Branham. **The council voted 6-0, to approve.**
