

TERMS AND CONDITIONS OF SALE

1. Keen Lifestyle Membership Programs

Keen Lifestyle offers four types of monthly programs:

- **Keen Lifestyle Basic Membership**
- **Keen Lifestyle Classic Membership**
- **Keen Lifestyle Premium Membership**
- **Keen Lifestyle Platinum Membership**

By purchasing any of the above programs, the Customer agrees to enter into a monthly plan with Keen Lifestyle.

The Customer shall make the first quarterly payment for the selected program upon signing up.

The Customer shall be liable for the subsequent monthly, quarterly, semi-annually or annually payment eight (8) days in advance.

The Customer may terminate the program with eight (8) days written notice to be sent to info@keenlifestyle.com.

There will be a rejoining fee of \$75 should customer decide to return back as Keen Lifestyle Member after terminated the program.

2. Order and Delivery

These Terms and Conditions shall apply to all food delivery orders that are placed with Frunatic Pte Ltd ("we", "our" or "us"); whether via our website at www.frunatic.com, through our Delivery Hotline (+65 6736 0288), or through any of our Wellness Consultants. By placing your food delivery order with us, you acknowledge that you have read, understood and agreed to be bound by these Terms and Conditions.

2.1 Payment Policy

- 2.1.1 You are required to make payment via cash, cheque, debit card, credit card, paynow or funds transfer (via ATM or i-Banking) when you place your order. Payment must be made before or during consultation.
- 2.1.2 We will not process and deliver your order unless we have received advance payment from you. We do not accept cash payment upon meal delivery.

2.2 Delivery and Surcharges

- 2.2.1 Our delivery hours are from 10.00am to 1.00pm daily, Monday to Sunday.
- 2.2.2 We make every effort to deliver your meal within the specified delivery time. However, please allow one (1) hour buffer time as delivery timings might be affected by unforeseen circumstances such as weather conditions or traffic/parking restrictions.
- 2.2.4 All scheduled delivery times stated, agreed or represented by us are meant to be indicative estimates only, and we will not be bound by or responsible for any inconvenience or loss arising to you from late deliveries.
- 2.2.5 Our food and delivery service is subjected to the availability of our resources, and we reserve the right to cancel or reject any order that you may have placed with us.
- 2.2.6 For delivery to certain public places, locations with limited access or locations with postal codes starting with 01, 02, 03, 04, 05, 06, 07, 08, 17, 18, 19, 22 and 23; we reserve the right to request customers to kindly meet our delivery representative at the nearest designated location (e.g. where it may be less remote, for reasons of safety etc.). Kindly refer to the Appendix A - List for the affected locations for the Postal Districts/Codes mentioned above.

2.2.7 In the event that no one is present at the delivery destination to receive the meal, we will treat this as a delivered meal and there will not be any replacement meal.

2.3 Order Policy

2.3.1 All orders must be made at least 3 working days in advance.

2.3.2 **Any Payment made for Purchased Order is strictly non-refundable.**

2.3.3 We do not accept any changes made within 3 days of the scheduled delivery. All changes must be made **3 days in advance** prior to delivery date in writing via email.

2.4 Other Terms and Conditions

2.4.1 We advise that all meals are to be consumed within two (2) hours upon delivery/collection. To the fullest extent permitted under law, we disclaim all liabilities and will not be held responsible for any losses or consequences arising from the consumption of meals two (2) hours after delivery/collection time.

2.4.2 The menu description may be different from the actual food and beverages received as we have customized the meal according to your assessment results.

2.4.3 We accept no liabilities for your purchase of our products from any other third parties apart from us. We will not be a party to any dispute or disagreement that may arise between you and any third party in relation to the sale and purchase of our products.

2.4.4 While every care has been taken in providing this information, Frunatic Pte Ltd or its agencies cannot be held responsible for any inaccuracy.

2.4.5 Access to our website or delivery hotline may be suspended temporarily without notice in the case of system failure, maintenance or repair or for any other reasons. We shall not be liable to you or any third party for any damages or loss whatsoever, including but not limited to direct, indirect, punitive, special or consequential damages, loss of income, loss of revenue or profits, lost or damaged data, or damage to your computer, software, modem, telephone or other property, arising directly or indirectly from:

(i) Your access to or use of our website or delivery hotline;

(ii) Any loss of access to or use of our website or delivery hotline, howsoever caused;

(iii) Any inaccuracies or incompleteness in, or errors or omissions in the transmission of the contents on our website; or

3. Consultation

3.1 Late Arrival Policy

Customers who have breached or are in breach of the terms and conditions contained herein and Customers who have been permanently or temporarily suspended from use of any of the Services may not use the Services even if they satisfy the requirements of this Clause 3.2.

While we endeavor to respond promptly to notices from you, we cannot guarantee that we will always respond with consistent speed.

10 General

1 Definitions advertising

- 1.6 "Losses" means all penalties, losses, settlement sums, costs (including legal fees and expenses on a solicitor-client basis), charges, expenses, actions, proceedings, claims, demands and other liabilities, whether foreseeable or not.

- 1.17 "Terms of Use" means the recitals, Clauses 1 to 11 and any Schedules to these terms and conditions.sxc
- 1.18 "Trademarks" means the trademarks, service marks, trade names and logos used and displayed on the Platform.
- 1.19 "you" and "your" refer to the individuals over the age of 18 or otherwise under the supervision of a parent or legal guardian.

2 Interpretation

Any reference in these Terms of Use to any provision of a statute shall be construed as a reference to that provision as amended, re-enacted or extended at the relevant time. In the Agreement, whenever the words "include", "includes" or "including" are used, they will be deemed to be followed by the words "without limitation". Unless expressly indicated otherwise, all references to a number of days mean calendar days, and the words "month" or "monthly" as well as all references to a number of months means calendar months. Clause headings are inserted for convenience only and shall not affect the interpretation of these Terms of Use. In the event of a conflict or inconsistency between any two or more provisions under these Terms of Use, whether such provisions are contained in the same or different documents, such conflict or inconsistency shall be resolved in favor of Frunatic and the provision that is more favorable to Frunatic shall prevail.
