Entries - Are due by midnight Thursday, August 23nd. Entries made after this date are subject to a \$15.00 late fee. A cancelled entry without a good excuse, vet or Doctor letter/email is subject to a \$20 no show fee. Telephone and email entries accepted. Cheque or cash payment day of accepted. No e-transfer fee. Scanned entry forms may be emailed to "stevenscreekshows@gmail.com". Please notify us if you are not coming.

-At the pre-entry, entry and PT level riders may enter two full 3 phase divisions. At T and 1.05 riders may only enter one three phase division.

Tentative Schedule-Tentative schedule:

Free Services

We will be providing stadium and cross country course walks with experienced coaches for anyone interested for free. Warm up help will also be available at request for the jumping phases. Time will be scheduled so that the judge can speak to each competitor after their test.

Rules and Regulations

-Horses will be scored as per regular eventing rules but coaching of the rider is allowed **only** after a disobedience on a jumping course or going off course in dressage.

-There is no tack check but regular eventing tack rules will be enforced. Jackets are not required in the beginner classes.

-Broken stadium jumps will be charged to the rider.

Dressage

Tests for the 3 phases will be the SAME as at our July 22nd Event and in a 20x40m.

- Entry and Pre-Entry - Entry Test 1; Pre-Training - Test 1; Training - Test 1; Prelim - Test 2

Riders may choose to do a second test of choice for practice - if not in the prize list please specify on the entry form.

If riders have a particularly bad time in their competition dressage test they may ride their dressage test a second time to correct errors or for practice. The first test will be scored for prizes. Time will be allowed for a second test ride or to speak to the judge. The judge will not mark a test paper for the riding the same test twice but the judge will comment verbally with the rider after the test.

Stadium

Unlimited clear rounds are allowed after your judged round. The first round at a specific height counts towards your 3 phase score. Clear rounds are allowed only at or above the level you are competing.

Cross Country

-There will be no preliminary 3 phase division. Riders may complete a preliminary dressage and stadium and then school cross country.

-Riders are expected to stick fairly closely to their course for timing reasons but they may opt to go around a jump or jump a fence of another level that is near their fence. Horses will be judged as per an event and penalized for refusals, run outs etc.

-Riders may school the cross country at the end of the day after competing if things did not go well. This service is included in the three phase fee. Riders may also pay separately to school after riding dressage and stadium.

-Classes are subject to change depending on entry and outside requests. Riders must wear properly fitted ASTM/SEI or BSI approved helmet and acceptable footwear.

Prizes - Prizes for top placings and ribbons to 10th. Divisions will be split Junior Senior if entries warrant.
